



**BHS CHOIR SPRING 2018 TRIP**  
**STUDENT TRAVEL CONTRACT**

This contract between \_\_\_\_\_ (Student) and the Bowie High School Choir commits the Student to participate in the Bowie High School Choir Spring trip to Walt Disney World in Orlando, FL, March 7-12, 2018 .

The student AND student's parents/guardians agree to the following:

1. The cost of the trip is \$951.00.
2. I understand that my \$50.00 Activity Fee must be paid in full before I can sign up for this trip.
3. This signed contract and a non-refundable deposit of \$225.00 must be returned to the BHS Choir Director on or before November 10, 2017 in order to hold a reservation in the student's name.
4. The price of this tour is predicated on participation by a minimum of 23 people. Therefore, I the student, understand that if for any reason I am not able to go on the tour as herein committed, I must notify the BHS Choir Director in writing. I also understand, that I may not be eligible for refund.
5. If cancellation is made within 60 days of departure or after final payment, no refund will be offered.
6. My only recourse is to offer the next person on the waiting list the opportunity to buy my trip. If there is no waiting list, my trip maybe offered to any current member of the Bowie High School Choir who is not restricted from attending the trip. No other refunds will be expected or sought after from AISD, Bowie High School, the BHS Choral Department, or the BHS Choir Booster Clubs.
7. Unused materials or items purchased will be disposed of in the most economic manner mitigating damages to the AISD, Bowie High School, the BHS Choral Department, and the BHS Choir Booster Club.
8. In the event Bowie High School Choir should cancel the tour, the student will receive a proportional refund of the reclaimed funds from the event providers.
9. All payments for the trip will be made on time and per the following schedule. If I, the Student, am late with a payment and have not made appropriate arrangements with the BHS Choral Director, my tour place may be forfeited to the first person on the waiting list.



10. You may pay for the entire cost up front, or you may adhere to the following Payment Schedules:
  - a. Non-Refundable Deposit (Due November 10, 2017): \$225
  - b. December 10, 2017: \$242
  - c. January 10, 2018: \$242
  - d. February 1, 2018: \$242
  
11. If financial hardship is the only limitation to the student participating in this trip, the student may schedule an appointment with the Director to discuss options.
  
12. The Bowie High School Choir, Bowie High School Choir Booster Club and Arlington Independent School District give notice that all arrangements for transportation, conveyance, hotel accommodations and all tickets and coupons issued by them, are made by them as agents upon the express condition that they shall not be liable for student's injury, damage, loss, accident, delay or irregularities which may be occasioned either by reason of defect in vehicle, or through the acts of default of company or person engaged in conveying the passenger, or in carrying out the arrangements of the tour(s), or otherwise in connection therewith, or any hotel proprietor or servant.
  
13. The Bowie High School Choir, Bowie High School Choir Booster Club and Arlington Independent School District accept no responsibility for losses or additional expenses due to delays or changes in bus, train, plane, or other services, sickness, weather, strikes, war, quarantine, or other causes, or act of God. Student and parents/guardians agree to release Bowie High School Choir, Bowie High School Choir Booster Club its agents and employees from all claims arising out of such events, act or omissions.
  
14. Student and parents/guardians understand that The Bowie High School Choir, Bowie High School Choir Booster Club and Arlington Independent School District has offered these tours and itineraries based on fares and prices at the time of offering, and grant The Bowie High School Choir, Bowie High School Choir Booster Club and Arlington Independent School District the right to change, add or withdraw any tour announced in this proposal and to make alterations in the itineraries and program costs as may be found necessary due to change in transportation costs, lack of participation or other cost differences. All offerings are subject to confirmation and/or an adjustment when payment for the tour is made. Student and parents/guardians understand that such changes in the program, including increases in program prices, are not grounds for withdrawal.
  
15. I understand that Bowie High School Choir will enforce the AISD Student Code of Conduct as outlined in the Student Handbook. Furthermore, Bowie High School Choir



will require participants to adhere to any rules or standards that it establishes and communicates. Failure to comply with said standards and rules could mean immediate termination of student's participation in the program. Costs due to termination are at my own expense and unused portions of my program may not be refundable.

16. Student and parents/guardians understand that use of alcohol or tobacco products by minors or the use of illegal drugs is grounds for immediate rejection from the tour program.
17. The Bowie High School Choir, Bowie High School Choir Booster Club and Arlington Independent School District is not responsible for student's well-being while not with the group.
18. Any statements made by participants or photographs taken of participants while on tour may be used by the AISD, Bowie High School, the BHS Choral Department, and the BHS Choir Booster Club in any future publicity materials or promotional publications.
19. Student and parents/guardians understand that the AISD, Bowie High School, the BHS Choral Department, and the BHS Choir Booster Club, its agents and employees are not responsible for any financial liability or obligation which I may incur, or injury or damage to the person or property of others which I may cause or contribute to while on this tour.
